Two no's Urban Primary Health centres (UPHC) one is at Choudwar city of Choudwar NAC & another

one is at Jagatpur city of Cuttack CMC of Cuttack district are running & managed by Social Awareness Institutions (SAI). In Key Focus Areas in PPP mode with the support of OSH&FW Society under National Health Mission (NUHM).It is the explicit mandate of the UPHC to provide priority services to urban poor people, especially those in most difficult circumstances such as street and slum children, the aged, disabled, single women, unorganized workers in unsafe occupations, and survivors of violence. The UPHC not only integrate RMNCH+A services but also integrate all vertical disease control programs and non-



communicable diseases program. Both the UPHC also work and cover the preventive, promotive and curative services.

# **Objectives of UPHC**

• To provide comprehensive primary health care to the urban population in general and particularly the urban poor.



- To achieve and maintain an acceptable standard of quality of care.
- To make the services more responsive and sensitive to the needs of the urban poor.

# Scope of work in the UPHC

**OPD timing & Consultation:** OPD services are providing twice in day i.e. **(8.00 am to 11.00 am)** in morning and **(5.00 pm to 8.00 pm)** in the evening. Free medical consultation provide to the patients in the OPD. With Provision of two no's observation beds in the UPHC.

food. On this program all the HW(F), ASHA, MAS members were present.

On dated 05/08/2018 a leprosy campaign program was organised at Kapaleswar UPHC Nuasahi by HW(F) Sibani Acharya, ward no-17 , Sanjay Swain(pharmacist) , Lipsita Maharana(sn).on that program the members of MAS,ASHA & local peoples were present give them awareness and take oath by the present peoples.

Swachha Samudaya program was organised at ward no.-17,at summer season .in that

# Targeted Intervention (TI) Project FSWs and MSMs in Nuapada District

#### **Project Background**

It is estimated that more than 90% of HIV transmission in India is related to unprotected sexual intercourse or sharing of injecting equipment between an infected and an uninfected individual. Not everyone in the population has the same risk of acquiring or transmitting HIV. Much of the

HIV transmission in India occurs within groups or networks of individuals who have higher levels of risk due to a higher number of sexual partners or the sharing of injection drug equipment These high risk groups (HRGs) of individuals who are most at risk include:

- Female sex workers (FSWs)
- High-risk men who have sex with men (MSM), and trans-genders (TGs)
- Injecting drug users (IDUs)

The broader transmission of HIV beyond these HRGs often occurs through their sexual partners, who also have lower-risk sexual partners in the "general" population. For example, a client of a sex worker might also have a wife or other partner who is at risk of acquiring HIV from her higher-risk partner. Individuals who have sexual partners in the highest-risk groups and other partners are called a "bridge population", because they form a transmission bridge from the HRG to the general population

# Link Worker Scheme (LWS) Project

#### **Target Area**

A broad mapping was done in consultation with the District Health Unit, ICTCs, DSRC, RNTCP, CHCs and other secondary stake holders like PRI members, labour department, labour contractors etc. The 20 clusters were selected at an average of 5 villages in a cluster and 123 villages in total.

#### **Human Resource Recruitment:**

Recruitment for different posts was done as per the guidelines of NACO. There was no DRP, and M&E cum AA turnover .There were Zonal Supervisors turnover from 1st September-2018 in the project. Only two Cluster Link Workers were changed and for the posts for cluster link workers advertisements were done in the form posters in the villages. A panel consisting of OSACS officials/representatives of local health department and senior NGO staff selected the candidates through written and viva voice test

#### **CAPACITY BUILDING:**

**Induction Training:** It is a rule in Social Awareness Institution that induction training shall be given to the new staff within 15 days of their joining. In this context induction trainings were organized twice for the new CLWs in which they were oriented on Goal and objectives of SAI, its different policies, goal and objectives of Link Worker Scheme Project, OSACS, NACO and the basics of HIV , AIDS. They were also trained on the different reporting formats and their implications.

**Refresher Training of Link Workers:** Though was no budgetrefresher training of Link Workers was organized when new CLW were recruited in which the old and new Link workers were capacitated the behavior change communication including body mapping, condom Promotion, and other basic knowledge of Link Worker Scheme (LWS) Project.

#### BEHAVIOUR CHANGE COMMUNICATION:

The 20Link Workers in 40 GPs of the 5 blocks of the district listed out the HRGs and vulnerable population in their respective categories. There after they prioritize them with respect to vulnerability and started interacting with them. Their communication processes with the target group was one to one counseling, one to group counseling. Different IEC materials like charts flip books, stories and models were used to communicate different massages on prevention, care and support. At the outset the link workers felt it difficult to discuss sexual issues especially with the FSWs later this was incorporated in their training and then they were empowered to help the target groups to assess their own risk, make risk reduction plans and motivated for correct and consistent use of condoms. Following are the achievements of the project:

#### **COMMUNITY OUT REACH**

To enable an enabling environment, the link workers, supervisors, DRPs discussed with different secondary stake holders like PRI members, ASHAs Anganwadi workers, village leaders, SHG members regarding the vulnerability of the area and worked out plans to protect people from HIV infection, ensure elimination and stigma and discrimination, clear the myths and misconceptions, community care and support of the infected and effected by HIV.

It was observed that there was wide acceptance of the HIV/AIDS intervention in the district from all sectors. Health care professionals have extended their hands to support the workers in carrying out their responsibility, guide them and welcome them in all activities of the health department.

Similarly our volunteer, workers participated in the Pallibashas, Gramsabhas, GP level meetings, organise special meetings with the PRI members to seek their attention towards the prevention, care and support of HI/AIDS. Their knowledge on HIV/AIDS increased and they realized the need of coordinated approach to fight against HIV/AIDS.

#### **REFERRAL AND LINKAGES**

After the vulnerability assessment of the target groups they were referred to different service delivery centers like ICTC, PHC, TB centers, ART center. 8969persons were referred to ICTC out of which 8969 were tested and 10 were found positive from 2no.Maigrant ,1 no Trucker, 6 no Other vulnerable and 1 no ANC . All persons were referred to ART center, Balangir. All these PLHIVs were registered at the ART center and 10 of them have started taking ART drugs. 2116 persons were referred to the STI clinic,151No of screened for syphilis.

#### CONDOM PROMOTION

Correct and consistent use of condom plays an important role in HIV prevention. In Nuapada district, the majority of the HIV infection was through sexual route and hence condom promotion was given utmost importance in the project. The workers explained the benefits of condom use, correct way of using it be demonstrating condoms before the target groups both in one to one and group interactions. It was observed that the demand for condom has a steep increase after the Link worker Scheme intervention in the district. To make condom accessible and available, condom out lets were established in almost all the villages of the project area. 123 out lets have been established. The outlets were mainly with the ASHAs, AWWs, betel shops, dhabas, wine shops.Free Condoms were also distributed through the Link workers to HRG and demo station in the field & in condom depo. Social Marketing condom also selling to the target population for and in the programmes undertaken by the project.5289 pieces of free condoms were distributed to the High risk target groups. Social marketing condoms were displayed and2777 no pieces distributed to the target groups in different exhibition stalls to aware people about their availability.

#### **PLHIV** networking meeting:

The first Network of positives in Nuapada in the name of **JeevanDhara** was formed. Networking meeting for the people living with HIV/AIDS was organized 24<sup>th</sup> April-18 SAI Nuapada office, and 2<sup>nd</sup> networking meeting for the people living with HIV/AIDS was organized on date 11<sup>th</sup> February-2019 at SAI Project office, Khariar.

### World AIDS Day:

World AIDS day was observed on the 1st December 2018 jointly by SAI, CHC, Khariar, Block administration, ICDS and other NGOs. The ABDO, Medical Officer in charge, CDPO and other block level officials were present. The rally was flagged off from Raja A.T.HighSchool ground by the Medical Officer I/C and the Head Master of RATHS and moved throughout the town reciting slogan on HUV/AIDS. Cluster Link Workers, Volunteers, ASHA, AWW participated in the programme. Then the participants of the rally assembled at Raja A.T.High School where there was an awareness meeting, Speakers like BarunaBaghar, Counsellor, ICTC,

Medical Officer, CDPO, PHEO, BPM spoke on the different aspects of HIV/AIDS. Artists of KhariarSanskritikAnusthan presented a street lay on HIV/AIDS.

Aquizcompletition was held after the meeting in which persons given correct answers were given prizes.

## **Advocacy Meetings**

Advocacy meetings at the block and GP level were conducted for a stigma free environment, early detection, 100% testing of pregnant mothers. Keeping in view of the expected draught situation it was anticipated that there will be more migration this year in comparison to the last years. Hence the PRI members were requested to implement the MGNREGS programme properly so that the migration will be less and to educate the migrants for prevention.

## **Health cum Testing camps**

Health cum HIV screening camps were organized in remote places from where people find it very difficult to reach to the ICTC for HIV screening. Hence camps were being organized in consultation with the counselor, ICTC and with MHU team. It was observed that there were more than 100 testing in all the camps and also benefited a primary treatment such as sick, and check BP ,high passer Low passer&ect. This reflects the increase in the awareness of the people on HIV/AIDS.

# **Stigma Reduction Activities:**

In a village in Bargaon GP of Sinapali block one ANC was found HIV positive. Her husband was also positive. But the husband refused to get ART services or give his wife any medicine to prevent the child from HIV infection. In spite of several attempts by the ICTC counselor, Zonal supervisior, Cluster Link Worker, they could not be registered. Rather the male threatened dare consequence if anybody visits their house. Thus a stigma reduction activity was planned in the village in which different stakeholders including health department staffs and PO TSU explained regarding PPTCT as a result of which the couple were registered with ART center, Balangiir.

#### **MONITORING AND SUPERVISION:**

#### **Joint visits:**

Joint visits were held with ICTC counselor, PO, TSU, staffs of TI NGO periodically for monitoring the progress of the project and avoid duplicity.

This too helps in identifying vulnerable population in the respective areas. There are clients of the HRGs of the TI who hail from the Link Worker Scheme Project area. Thus it helps us in prevention strategy.

# **Discussion Topic**

- ➤ . New key population Registration There should be at least 30 % new registration of key population in T.I. Projects and the LWS project should plan to take new areas in place of areas covered completely.
- > STI diagnosis There should be 20% STI cases in a HRG area thus the projects should plan accordingly
- > During the discussion another issue was highlighted that was free bus pass for PLHIV. In this point where the free transportation facility provided to PLHIV for attending ART center for taking ART medicines and treatment to PLHIV since 2007, all PLHIV are allowed free transportation
- ➤ facility by Govt. and private buses for traveling to ART center. But neither the OSACS nor the ART center provide the free bus pass to the PLHIV of Nuapada District.
- Analysis and discussion with both TI and LWS staff PO indicated the issue of Labour Card to the LWS project. LWS staff stated that the labour are facing many problem to get their daily wages. In this regards PO said to keep all the legal document and advocacy should be done with Labour officer..
- ➤ To link the Target groups with other social security schemes. Then LWS staff stated that one of the HRG was facing difficulty to get TB medicine from the ART center and CHC RNTCP center. And he said that the TB medicine is not available in ART center and RNTP center. In this issue PO suggested that follow the proper way and keep proper document. Then we can inform it to the OSACS.

#### **BEST PRACTICES**

# **IEC stall in Mega exhibition cum festivals:**

The project creates awareness in Mega exhibitions like KhadialMahotsav, block and district level MaragudaUtsavs where thousands of people come. Exhibition of posters on STI, RTI, HIV, Social Security Schemes were displayed, Individual counseling, group counseling, written quiz, STI treatment, HIV testing was done, Condoms were distributed. As in Nuapada district only one ICTC completely functional with laboratory technician of OSACS, most of the persons at risk can not test themselves for HIV infection.

# Creation of cultural troupes from volunteers for mass awareness:

With an objective to reach maximum number of people with less expenditure, local troupes including local artists and volunteers. There was a one day orientation programme of the troupes, script were developed for street play and pala and the troupes performed in and around their gram panchayat as a result of which 56 artists were trained and the messages reached the people due to the use of local language in the programmes.

# Training of adolescent girls on STI/RTI/HIV/AIDS

The adolescent girls are trained on STI/RT/HIV/AIDS in coordination with ICDS. Though Anganwadi workers should have meetings with adolescent girls every Saturday, they are not capable of educating the girls properly on these issues hence they welcome the staff of LWS project to train the adolescent girls. This activity could be done without incurring any expenditure.

# **IEC** material in local language:

Wall writing in 7 important places was done in local language to bring mass awareness on HIV/AIDS.

# A REPORT ON OBSERVATION OF "WORLD KIDNEY DAY"

SAI-TI observed World TB Day-2019 at Warehouse, Jagatpur on 24th March'2019. Mr. Jogesh

Kumar Rout, Zonal Manager of warehouse was presided the meeting and Mr. Srikanta Mohanty of SAI-TI joined as chief speaker in the observation ceremony. Welcome address given by Project Manager Pradip Kumar Swain and he described about World TB Day which celebrated all over the world on 24<sup>th</sup> March of each year in order to raise the public awareness about the about the devastating health, social and economic consequences of TB, and to step up efforts to end the global TB epidemic



Mr. Srikanta Mohanty more precisely describe about TB as world's deadliest infectious killer. Near about 4500 people lose their lives by TB every day and close to 30,000 people fall ill with this preventable and curable disease. Global efforts to combat TB have saved an estimated 54 million lives since the year 2000 and reduced the TB mortality rate by 42%.

Project Manager high light the theme of World TB Day 2019 - 'It's time' – means it's the time we should act following:-

- scale up access to prevention and treatment;
- build accountability;
- ensure sufficient and sustainable financing including for research;
- promote an end to stigma and discrimination, and
- > promote an equitable, rights-based and people-centered TB response.

Mr. Jogesh Kumar Rout, Zonal Manager of warehouse describes his experience that he has observed during dealing with labours since long years. He told that many laboura always ignore about their health problem due to earning money and get as much money for their family. As they are staying outside from their family they always try to income more and feed their family. Mr. Pradip Kumar Swain added that labours are usually taking their food from dhaba or nearby small hotels where they preferred spicy food and liquor. Most of the labours taken liquor and Ganjei as

they thought that by taking liquor and Ganjei they will work many times without pain and with concentration. He explained the negative aspect of taking liquor and Ganjei. He advised present labours to avoid these bad habits and suggested to avoid cold. He also advise them to take prevention by check-up periodically at health camp provides by SAI-TI. He also suggested to access the facilities provided by Urban PHC running by SAI which is situated at Jagatpur and Choudwar area of Cuttack district. .Ms. Jyotishree Das, M&E given vote of thanks to preset dignitaries and truckers.

# **World Aids Day**

# **Background**

World AIDS Day originated at the 1988 World Summit of Ministers of Health on Programmes for AIDS Prevention. Since then, every year United Nations agencies, governments and civil society join together to campaign around specific themes related to AIDS. As per the Activity schedule Selection of the school was the first month activity. Before selection of school there is a short orientation provided to all staff regarding school selection process. Just after the orientation staffs are fixed the selection criteria, and developed the data collection format.

# **Enabling Partner Community to revive ecology-based sustainable livelihood and assert labour Rights**

#### (i) Land, Forest, water and Commons:

Awareness has been created about land rights and forest rights in all operational villages.



Homestead Land was allotted to 122 members for construction of house under different schemes but 30 male and 12 females received land title of 4 decimals each. 10 community member received title for agriculture land amounting to A14.6C. Till date no individual title was given to any Nontribal forest dweller. The issue was discussed with the SDLC and the Collector. Rallies and protests were done by the people but till date their claim was unheard. It has been decided to organize a state level congregation and fight for the rights of the NTFD of Odisha.

44 Forest Right Committees were awaked on the Forest Rights Act and the procedures of getting rights under the act 1551 males and 20 female submitted individual claims.119 male and 10 female received titles. Four gramsabhas were organized and the Joint verification reports were approved.

5 numbers of trainings were organized on ecological farming like organic manuring, pesticides, procurement of seeds, and preservation of seeds.167 males and 83 females attended the trainings. Village level meetings were organized and the farmers were sensitized on organic farming and 9439 farmers are practicing organic farming. During the last 15 years due to the publicity people succumbed to the craze of immediate hike in production and had left cultivating traditional seeds.

But continuous draught for four years opened the eyes of the farmers when they observed that farmers cultivating traditional seeds got some yield from their land. Trainings, meeting and practical experience helped the farmers understand the benefits of ecological farming and were interested to cultivate indigenous seeds. Traditional paddy seeds were collected from "DesibihanSurakshaManch" and were distributed among the 336 farmers through 28 Seed banks. 4582 farmers cultivated traditionally and were quite happy getting more than the hybrid seeds without spending money for chemical fertilizer and pesticides. The farmers went on a exposure visit and learnt the benefits of organic farming and the way farmers of Bargarh district have preserved more than 100 varieties of paddy seeds. The farmers of Nuapada district then got together in the "DesiChasiSammelan" organized at Khariar. Farmers exchanged experience and success stories and then exchanged traditional seeds.

#### Labour and Livelihood Rights with focus on Women workers



People of all the operational villages were sensitized on a regular basis on the labour rights and entitlements. Staff and volunteers support the workers for filing application for job under MGNREGS, getting pluckers' card for kendu leaf plucking, linkage with Welfare boards for construction workers as well as kenduleafpluckers for different benefits under the welfare boards.

The staff, volunteers and labour leaders were trained on MGNREGS, RTI and other entitlements. 25 cases were taken up for the payment of wages under MGNREGS out of which 16 were solved and payments were

released.

342 males and 120 females attended skill building training organised at the GP headquarters by the government.

The issues of the workers had been resolved by facilitating public hearing advocacy with the government offices, media advocacy.

42 Organisations of unorganised workers was formed from village level, block level and district level. The labour leaders sit quarterly to discuss issues of labours and accordingly steps were taken.

#### Livelihoods:

44 male and 52 females were trained on bamboo craft. They were trained in two places for 8 days each on design development. The bamboo craft artisans were facing problem in getting bamboo and hence forest department was requested to provide seedlings which were later planted by the paharia community. After the training the paharias( bamboo craft artisans) learnt to make decorative and daily use items which increased their income by less input of bamboo.

Kendu leaf cards were given in 5 villages where the pluckers were earlier selling through other villages. 106 male and 341 females got new cards in 2018 and earned Rs.1468770.00. The pluckers increased their income and also got benefits under the social benefit schemes. They will be getting bonus in the next year.

### (ii) Women's Rights, Women & Property

Perspective building of team and leaders was organized for three days in which 39 women leaders from different blocks participated. They were trained on the different legal rights of the women focusing on the single women including right to property, right to sexual health and the structures of the government to support the women to lead a dignified life. Women collectives were formed to address the issues of the women at the community level. Issues like increase in widow pension, financial support to single women for income generation activities, homestead land for single women.

The staff and leaders are members of the Regional Women Forum and the state level Single women Forum. One of the members has become the secretary of the state level organization. Issues of single women were identified at the district level single women convention and the team submitted a charter of demands to the collector, Nuapada.

#### (iii) Public Education and Child Rights

- Along with strengthening public education & making govt schools functional, please include interventions related to other childrights like survival, development, protection, participation and any innovative work with children focusing on girl children, children in difficult circumstances such

as NT/DNT children, children of seasonal migrants, street children and others.

 Out of School children enrolled in schools (girls, boys), SMC members trained on RTE and other CR provisions, how government schools were strengthened, new ICDS centres opened, bonded children, child labour rescued, scholarships accessed, child marriages prevented, any advocacy efforts on public education, studies or research carried out.

Child clubs were formed in 34 villages and regular meetings were held with the members in which children were



awaked about their rights like survival, development, protection, participation.

Block level trainings were organized in all blocks in which mothers were trained on the ICDS schemes, regular monitoring of the AWC. 8 malnourished children were referred to the NRC and were treated. AWC centers were made functional through regular community monitoring.

Children festivals and child parliaments were organized to increase the awareness of the children, parents and teachers about child rights, school safety, proper monitoring of MDM. These

programmes highlighted the issues of the children and enable them to raise voice against any injustice to them.

PRI, PTA, MTA, School cabinet were trained and sensitized on right to education and their roles and responsibilities. 72 schools on the operational area were functional in which child participation in the SMC in ensured, proper monitoring of MDM is done.

In all the 54 villages meetings were organized on prevention of early marriage. People took oath for preventing child marriage. Two communities resolved in their caste based organisations to prevent child marriage.

**Critical reflections and lessons learned:** what worked well, what didn't? If didn't work well, what could be a different strategy? How did you overcome risks?

The greatest challenge is the delay in payment of wages under MGNREGS. The work is measured in piece basis but payment is made on daily wage basis for which proper muster role is not maintained resulting in delay in payment. Advocacy required at the national level for the payment of wages on piece work basis.

# Jan Shikshan Sansthan, Balangiri Vocational Courses conducted

The ISS Balangiri is endeavoring to take up programmes with the objectives of achieving development in socio-economic, cultural and educational fields. During the period, as many as 80nos. of training programs which includes curriculum under NIFT, DAE, and MES course were conducted. Lectures, distribution of pamplets, street plays, International Day celebrations, competitions and participating in exhibitions is always a part and parcel of the training programme which enable the beneficiaries to widen the range of knowledge. The total number of 2000 beneficiaries were coveredunder the programme The target groups for JSS ,Balangir are clearly given in the guidelines issued by the Govt. of India. They include socio-economically backward and educationally disadvantaged groups of urban/rural population such as men, women and youth, employed, self-employed, neo-literates, prospective workers and their family members as well as unemployed youth. However, priority to be given is to adult neo-literates, semi-literates, SC, ST, Women and Girls, oppressed, migrants, slum/pavement dwellers and working children. In course of time, a number of administrative orders have been issued by the Ministry of Human Resource Development with regard to the target groups. Accordingly the priority target groups are SC, ST, OBC, Women and Muslim minorities. From the below table it is clear that females have been given priority in the vocational skill development programmes organized by the ISS Balangir. However, it may be appropriate that coverage is consistently increased year after year instead of more coverage ..
